



2012 Media application form

All photographers must apply in advance of the event. The application process will close 10 days prior to the event. All applications must be in by this date as on the day media sign on will not be allowed without.

The issuing of a media pass is entirely at the discretion of BDC Limited; the completion and submission of this form **does not guarantee** the granting of a media pass.

To sign on as accredited media you must provide the following information.

A: Original letter of accreditation from the editor or director of a recognized publication / agency / media organization relating to the specific event (without this, the application will NOT be considered)

B: Two examples of published work either from this year or 2011 (For applications to film please enclose 2 examples of previous work with relevant viewing figures)

C: Public Liability Insurance Certificate or verification of insurance from your insurance broker confirming cover of at least £1m

D: Personal Blogs/Websites will be considered but MUST provide proof of UNIQUE viewing figures for previous year.

E: Equipment used must be of professional standard. DSLR/SLR or professional film equipment.

F: : A digital passport photograph of the applicant

Due to overwhelming demand BDC will not accredit any photographers for drivers or teams. Film Crews will be limited and on a first come first served basis.

BDC will accredit websites/electronic media at its exclusive discretion, for which BDC may charge a rights fee. (Guidance: websites reproducing only press releases will not normally be considered, and those which sell photographs will be required to be licensed, additional to the photographer supplying the images)

In consideration for The British Drift Championship accepting my application for accreditation and for issuing me with a media pass which enables me to move outside the approved enclosures at the Event detailed above, I agree as follows.

1. I have read, understood and agree to abide by all applicable terms, conditions and rules and regulations pertaining to the Event relating to the accreditation) and as otherwise issued by BDC from time to time and made available to me, and to the instructions of officials. I acknowledge that BDC shall be entitled to remove me from any of the Venues and/or to remove my media pass in the event of my breach of or non-compliance with such terms, conditions or instructions.
2. I am over 18 years of age. I am physically and mentally fit to carry out my function and that I will inform the organisers immediately should any change in my condition occur which I have reason or ought to have reason to believe would affect my ability to carry out my function.

I acknowledge and accept that due to the nature of motor racing there are inherent risks and dangers to persons attending an event and despite BDC taking all reasonable precautions, accidents can happen. Further, I accept that certain areas of the Venues (inparticular but without limitation the pit garages, paddock, track, pit lane and any areas adjacent to the track) present additional risk to persons present in any of those areas during an Event. I hereby accept and acknowledge these risks and attend at a Venue at my own risk and I will undertake my functions with due and proper regard for my safety and that of others.
4. I Understand that the Maxxis BDC water mark must be displayed on all electronically published images where possible. And that ALL IMAGES PUBLISHED TO ANY SOCIAL NETWORKING SITE MUST HAVE THE MAXXIS BDC WATERMARK DISPLAYED. Failure to do so will possibly result in my pass being revoked.
